Definitions:

- Organization: Reflections by Minke van den Bergh.
- Participant: Person or authority OR owner/possessor of one or more dogs that participate in an event organized by the organization.
- Event: An occasion organized by the organization
- Event Grounds: Location where the event takes place, including the parking area

General:

- All these terms and conditions conform to the current General Data Protection Regulation.
- Registers between 7 september en 1 december 2019 €180,-
- Registers between 1 december 2019 en 31 januari 2020 €200,-
- All named prices include VAT unless otherwise agreed.
- Participation for two days and includes:
 - lunch for both days
 - coffee/ tea
 - parking

Rights and obligations of the organization:

- The organization can at its discretion change, move or cancel the event in case of bad or extreme weather conditions or unforeseen circumstances.
- The organization hereby declares to have knowledge of first aid for dogs.
- The organization reserves the right to refuse a dog/handler combination or remove the combination from the event in case of repeated unacceptable behavior, when the dog's welfare is in danger or if the Terms and Conditions are not met.
- The organization is not responsible for theft and/or damage in any form.
- The organization has the right to cancel registration of a client if payment isn't fulfilled in time.
- Decisions made by the organization and jury are always binding and will not be discussed.

Rights and obligations of the client:

- The registration form AND fee needs to be completed and in possession of the organization by **31 January 2020**. By completing the registration form the participant agrees to these terms and conditions.
- Termination of registration before 31 december 2019 leads to a FULL refund of paid registration fee.
Termination of registration before 31 januari 2020 leads to 50% refund of paid registration fee
Termination of registration AFTER 31 januari 2020 leads to 0% refund of paid registration fee.
- Using physical and/or psychological corrections including excessive violence to correct the dog, is not allowed and will lead to exclusion from participation.
- Participants are required to equip their dog with a flat collar with buckle- or click closure or a well-fitted harness. Choker chains, prong collars and electric collars are not allowed on the terrain of the event and usage will result in exclusion from participation.
- During the event, dogs in heat are not allowed.
- The participant is responsible for all damage to persons or goods that is caused by the participant, any visitors brought by the participant, or any of the dogs brought by the participant. This includes damage to material from the organization, its staff, or the location of the event.
- Every participant is required to have a valid liability insurance that includes damage done by pets.
- Participation in the event is at risk and responsibility of the participant
- The participant hereby agrees to inform the organization about the health and welfare issues concerning their dog and all matters that directly influence the dogs performance or otherwise performance of other dogs.
- Participants are eligible for the event if their dog has had the required vaccinations according to Dutch law. For participants from outside the Netherlands a valid rabies vaccination is required.
- Payment for the event is due after confirmation of the sign-up and before 31 January 2020. If a participant does not meet this requirement, there will be no refund of payments done.
- Participation in the event is only guaranteed after receiving full payment within the agreed time limit and before 31 januari 2020 .
- Participants will receive an start number which will tell them when they will execute their exercises. If they are late for their exercise they will not be able to take a resit, and will receive a score of 0 for the exercise.
- Participants have the option to send any complaints about the event or organization via e-mail.
